

The 2017 M.L. Campbell® COOL! FREE! SUMMER! GIVEAWAY

OFFICIAL RULES

No Purchase Required to Enter or Win. There is no Entry Fee. A Purchase Will Not Increase Your Chances of Winning.

- GIVEAWAY/ELIGIBILITY:** The 2017 M.L. Campbell® COOL! FREE! SUMMER! GIVEAWAY (the “Giveaway”) is open only to (a) individuals that are employees or owners of a professional wood shop (b) legal residents of the fifty (50) United States or the District of Columbia, and (c) eighteen (18) years of age or older, or the age of majority in their state of jurisdiction, whichever is greater, at the time of entry. Employees of The Sherwin-Williams Company and related companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to participate in the Giveaway. The Giveaway is subject to all federal, state, and local laws and regulations, and is void where prohibited by law.
- SPONSOR:** The Giveaway is sponsored by The Sherwin-Williams Company, by and through its M.L. Campbell® Group, 101 W. Prospect Avenue, Cleveland, Ohio 44115 (“Sponsor”). The Giveaway is in no way sponsored, endorsed or administered by the Association of Woodworking & Furnishings Suppliers (“AWFS”).
- AGREEMENT TO OFFICIAL RULES:** Participation in the Giveaway constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules in a timely manner.
- ENTRY PERIOD:** The Giveaway will begin on July 14, 2017 at 11:30:00 a.m. Mountain Standard Time (“M.S.T.”) and will end on August 15, 2017 at 11:59:59 p.m. M.S.T. (“Giveaway Entry Period”). Entries received outside of the Giveaway Entry Period will be disqualified. Sponsor’s computer is the official time-keeping device for the Giveaway.
- ENTRY:** To enter the Giveaway, entrants must either (1) attend the AWFS Fair in Las Vegas, Nevada between July 19, 2017 – July 22, 2017 (the “Fair”) and sign up at the M.L. Campbell booth to receive a product demo and/or sign up to be a M.L. Campbell Insider, **OR** (2) go to <https://goo.gl/ctiRV4> to sign up to receive a product demo and/or sign up to be a M.L. Campbell Insider. It is free to sign up for a product demo or to be an M.L. Campbell Insider. Individuals will receive one (1) entry for signing up to receive a product demo and one (1) entry for signing up to be an M.L. Campbell Insider, for a maximum of up to two (2) entries per individual during the Giveaway Entry Period. Non-conforming entries are void and will be disqualified in Sponsor’s sole discretion.
- RANDOM DRAWING/ODDS:** Four (4) prize winners will be selected in a random drawing about five to seven (5-7) business days after the close of the Giveaway Entry Period from among all eligible entries received during the Giveaway Entry Period. The odds of winning depend on the number of eligible entries received during the Giveaway Entry Period.
- NOTIFICATION/REQUIREMENTS OF WINNERS:** Sponsor will attempt to contact the potential winner via telephone or email. If a potential winner cannot be contacted within three (3) business days after Sponsor’s first attempt to make contact, that potential winner will be deemed to be ineligible and disqualified. In such event, Sponsor may select an alternate, potential winner in a random drawing from among all remaining eligible entries received during the Giveaway Entry Period. Two (2) winners will each receive a custom-made wooden American flag (ARV: \$300) and two (2) winners will each receive a custom-made wooden cooler cart (ARV: \$300), for a total of four (4) individual prize winners. Sponsor selects the prizes granted to winners. Sponsor will ship prizes to the addresses provided by the prize winners at time of entry. Any prize details not specified in these Official Rules will be determined by Sponsor, in its sole discretion. No cash or other substitution may be made, except by Sponsor, who reserves the right to substitute the prize (or any portion thereof) with another prize (or portion thereof) of equal or greater value if the prize is not available for any reason, as determined by Sponsor in its sole discretion. 11. **GENERAL CONDITIONS:** Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the Entry process or the operation of the Giveaway or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner, including without limitation forging identity to submit more than two entries. ANY ATTEMPT BY ANY PERSON TO UNDERMINE THE LEGITIMATE OPERATION OF THE GIVEAWAY MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.
